Subject: Oregon School District Enrollment Projection Comparison

School districts in Oregon, and across the nation, experienced a significant drop in enrollment during the COVID lockdown. The question that has been discussed at length in the time since is, what level of enrollment recovery should school districts expect in the coming years?

Recent enrollment projections for ten other Oregon school districts have been gathered and reviewed. The attached Table 1 summarizes key data points from those projections. The following points send a strong signal of what should be expected.

- 7 districts projected increased enrollment over five years
- 6 districts projected increased enrollment over ten years
- 4 districts actually experienced increased enrollment*
- 9 districts experienced a lower actual enrollment than their middle projections.*
- Only Lake Oswego outperformed the projection, but the projection for that year was far below the projection for the following 5 years.

The data indicates that enrollment projections during, or in the immediate aftermath of, the COVID lockdown were optimistic in terms of anticipated growth. This sense of optimism seems to come through in some of the projection reports. The District's discussions with Flo Analytics and regional planners shows a tempering of that optimism in the planning community. While numerous factors contribute to the lower projections than originally anticipated in 2018, the trend does appear to be hardening into a new reality. That reality is based on lower birth rates, lower population growth, lower student generation rates, and slower housing development.

It is recommended that the District rely on the middle projections from Flo analytics, while planning to update the projections annually or biannually for the next 6-10 years.
