Format of your **NY Times** CIAs:

- A. Creative Title = make your own short snappy title to the topic 1 point
- B. Bibliographical Information = real title of the article, author, date article written, source of the article (www.nytimes.com) Yes, this needs to be from the New York Times 2 points
- C. Summary = in three to four sentences summarize the main points of the article, include at least **5 key facts** Your facts should be numbered or formatted so that it is easy to discern what you feel the facts are. Future predictions are **not** facts. 5 points
- D. Analysis = relate the article to economics using **3 or more economic note-card concepts**, for each concept answer why this is important to economics. Yes, this is about a paragraph per term of connecting the term to this news story and then explaining what the economical importance is of this term in this situation. 15 points
- E. Your opinion and ideas = 5 -7 sentences state your opinion, reflect upon the topic, go beyond the article to **connect with your own life and experiences**. 5 points
- F. Article = attach the article or the first page neatly to the back of your completed CIA, **emailed assignments** either copy and paste the article or hyperlink it 2 points
