## LOCAL INFORMATION PROVIDED BY YOUR DISTRICT

In the West Linn-Wilsonville School District, we are guided by the mission question: "How do we create learning communities for the greatest thinkers and most thoughtful people...for the world?" Part of the answer is a commitment to providing access and opportunity for each child, every child. Our District Goal #1 is to "Grow student achievement through the use of high-leverage instructional strategies that raise rigor and generate equitable outcomes for all students while eliminating opportunity and achievement gaps." This is reflected in our Special Education Focus Areas: Improving Instructional Practices, Creating Inclusive Cultures and Increasing Student Voice.

Over the last 5 years, we have increased inclusive participation in general education classes by eliminating self-contained classrooms and providing a full continuum of special education supports at every neighborhood school. This has led to an increased sense of belonging and more equitable access to high-leverage learning. Students served by special education are learning and performing at higher levels than ever before. During this time, our graduation rates for students with and without disabilities have continued to increase – to among the highest in the state.

We know that partnerships with parents are vital to student success, and we are committed to parent voice in their individual child's IEP as well as at the school and district level. For example, we have a District-Parent Collaboration Group that meets regularly to provide feedback and generate ideas for the special education team. Our parent survey results have increased from 33.3% satisfaction on the previous survey (in 2012) to 77.6% this year. We are proud of that growth and look forward to continued partnerships with parents.



